Purpose: Raise money for Carrollwood Elementary School - 100% of the proceeds from this event go directly to the teachers to purchase supplies, educational software and other classroom materials to enhance the learning environment for all students.

Average Attendance: 1,000+

Activities: Classroom activity booths, bounce houses & games, food, live entertainment, DJ, vendor booths, and silent auction.

Cost: \$50 for PTA members and \$100 for non-PTA members. Booths with items for sale are asked to donate 20% of sales back to the event. In addition, we ask that all vendors donate one item to our silent auction or kid bid.

Booth Details: Space is approximately 10' X 10'. You must provide your own tables, chairs, tents and display materials. Electricity may be available on a limited basis – please call if required; you are required to provide your own extension cords. Space set-up begins at 8 am on the day of event; all vehicles must be removed from HootieFest grounds by 9:30 am. Clean up needs to be completed by 3:00 pm.
